The magnitude of India's informal trade with Pakistan has been estimated using the Delphi technique.







2) Delhi-Mumbai-Dubai- Karachi-Lahore	12600	5756	2.18



Indirect route is 11 times longer than the direct route; 4 times more expensive than the direct route; but is 3 times more efficient...

# Policy Suggestions

- Trade normalization process should be completed
- Improvement in the trading environment
  - increasing awareness, reducing information asymmetries
  - improving connectivity
- Adopt measures that would encourage businesses to use formal banking channels
- Putting in place an innovative dispute resolution mechanism
