

Yashwant SINHA was born at Patna, the capital city of Bihar, India on 6<sup>th</sup> November, 1937. He received his school and university education at Patna. He obtained his Masters Degree in Political Science in 1958 from Patna University. Mr. Sinha joined the elite Indian Administrative Service in 1960 through a tough competitive examination and spent over 24 years holding important posts during his service tenure, a substantial part of which was spent in Finance & Commerce Departments. Mr. Sinha left the Indian Administrative Service (IAS) in 1984 and joined active politics. He was elected to the Upper House (Rajya Sabha) of Indian Parliament in 1988. Subsequently, he became the Finance Minister of India and held the

post from November, 1990 to June, 1991. Mr. Sinha was elected to the Lower House (Lok Sabha) of Indian Parliament in 1998 and again became Finance Minister of India in March 1998. He continued in that position until July 1, 2002. He was Finance Minister during a tumultuous period in the world economy as well as in the Indian economy. Mr. Sinha is a widely traveled person. He was the first India to be elected Chairman of Development Committee of the World Bank and the IMF in August, 2000 and facilitated inter-governmental consensus building on developmental issues. He was elected Chairman of the G-20, a group of systemically important countries from the point of view of the world economy. He was the first Finance Minister from the non G-8 countries to chair this Committee. Mr. Sinha was External Affairs Minister of India for two years from July 1, 2002 to May, 2004. Mr. Sinha was re-elected to the Lower House (Lok Sabha) of Indian Parliament in May 2009 and continued till May 2014. He was Chairman of the Indian Parliament's Standing Committee on External Affairs. He was also Chairman of the Parliament's Standing Committee on Finance.



**Isher Judge AHLUWALIA** is currently Chairperson of the Indian Council for Research on International Economic Relations (ICRIER). She is a renowned Indian economist, with wide experience in the fields of economic growth, productivity, industrial and trade policy reforms, and urban planning and development. At ICRIER, Dr. Ahluwalia is leading a major research and capacity building programme on the challenges of urbanisation in India. She was awarded Padma Bhushan by the President of India in the year 2009 for her services in the field of education and literature.

Dr. Ahluwalia was Chairperson of the High Powered Expert Committee on Urban Infrastructure and Services during 2008-11, which submitted its Report to the Government of India in March 2011. She is a member of the recently constituted Urban Institute of India which has been set up with Government of India and private sector as partners. She was a Member on the National Manufacturing Competitiveness Council and is on the Boards of a number of premier research institutes in India. Dr. Ahluwalia was Vice Chairperson of the Punjab State Planning Board from 2005 to 2007.

Dr. Ahluwalia is on the Board of Governors of IWMI (International Water Management Institute), and was Chairperson, Board of Trustees of IFPRI (International Food Policy Research Institute), Washington D.C., from 2003 to 2006. She was a member of the Eminent Persons Group (EPG) on India-ASEAN (Association of South East Asian Nations), an association established by the respective governments during the period 2011-12. She was also a member of the EPG of the Asian Development Bank from 2006 to 2007, which submitted its report titled "Towards a New Asian Development Bank in a New Asia" to the President, ADB in 2007.

Dr. Ahluwalia has authored a number of books, the latest being "Transforming Our Cities: Postcards of Change" (HarperCollins, 2014), and a co-edited volume titled "Urbanisation in India: Challenges, Opportunities and the Way Forward" (Sage India, 2014), which proposes critical reforms and policy interventions. She is also the co-editor together with Prof. IMD Little of "India's Economic Reforms and Development: Essays for Manmohan Singh" (OUP, 2013).

His recent research on regional issues includes: evaluation of Pakistan – Sri Lanka free trade agreement, non-tariff barriers in India-Pakistan trade, informal trade between India and Pakistan, trade in services across South Asia and Pakistan's prospects of cross-border foreign investment in Afghanistan.

He is an alumnus of St. Stephen's college, Delhi.





He did his Bachelors and Masters from Ball State University, Muncie, Indiana, USA.



PHD Chambers of Commerce.


Mr. Sehgal holds a bachelor's degree in Commerce and is a qualified Chartered Financial Analyst.
